

UZH International Summer Schools 2024 Regulations

Admission Requirements

To be accepted to a program offered within the University of Zurich (hereinafter "UZH") International Summer Schools, applicants must:

- Possess a sufficient command of English to be able to actively contribute to the classes, as
 demonstrated in their motivation letter, studies or work experience. Some programs may
 require proof of a certain English language level.
- Be enrolled at a university or other higher education level institution. (In individual cases persons with adequate qualifications may be admitted "sur dossier".)
- Present a motivation letter, outlining their interest in the course in a brief statement (no more than 500 words).
- Include a scan of the identity page of the passport, a CV, current transcripts and the high school or previous degree certificate with the application.

Application and Enrolment

- UZH International Summer Schools are selective, and places are restricted.
- Applications are evaluated as they come in (on a rolling basis) until the course is full or until
 application closes.
- Applications for the UZH International Summer Schools can only be made through the online registration form and by handing in the required application documents (apart from those applicants who are already enrolled at the UZH).
- By submitting the registration form, the applicant accepts these regulations.
- Course applications are evaluated by Global Student Experience and the relevant Faculty, Department and/or Course Director offering the course. Applications may be declined if a candidate does not meet the admission requirements or if the program is full.
- An applicant is only formally enrolled in the course once the tuition fee has been paid in full.

Housing

Housing is awarded on a rolling basis and subject to availability. Participation without the
housing option is available upon request or as soon as all available housing options secured
through Global Student Experience have been exhausted.

Tuition Fees and Payment

- Tuition fees are as advertised on the website and can only be paid in Swiss Francs (CHF) and through the online method outlined in the offer letter sent by Global Student Experience.
- The tuition fee may be paid in three installments. The payment may be reduced to two
 installments if the housing quota is exhausted or the applicant requests to book without the
 housing option. The first installment of CHF 200 must be paid within 15 days after receiving
 the offer letter in order to reserve a place and confirming participation in the UZH International
 Summer Schools.
- The second installment of CHF 800 must be paid within 30 days of receiving the offer letter in order to secure their housing during the UZH International Summer School. The remaining tuition fee (the last installment) must be paid no later than 15 April 2024. If the payments are



- not received by the relevant deadlines, UZH International Summer Schools reserve the right to cancel the admission and give the place to another applicant.
- If the applicant requests participation without the housing option offered through Global Student Experience or the housing quota has been exhausted, the remaining tuition fee (the last installment) must be paid no later than 15 April 2024. If the payment is not received by the relevant deadline, UZH International Summer Schools reserve the right to cancel the admission and give the place to another applicant.
- In the event of cancellation of a program offered within the UZH International Summer Schools by the UZH, the tuition fee (first, second and third – if applicable – installment) will be refunded.
- In the event of cancellation by the applicant, no refund will be provided (for exceptions see section "Cancellation by the Participant").
- Applicants eligible for a tuition fee waiver may have to pay a deposit in order to secure their
 place in the UZH International Summer Schools. In this case, the UZH will refund the deposit
 to the applicant by the end of the first week of the Summer School. However, no refund will
 be provided in case of cancellation by the applicant.
- Students already enrolled at UZH may be asked to pay a service fee to participate in the UZH International Summer Schools, which would be outlined in the UZH module catalogue.

Credits

- Each program offered within the UZH International Summer Schools indicates its expected learning volume in ECTS credits or their equivalent in the program description on the website. Participants are provided with a Certificate of Completion of the course if they satisfy attendance and the relevant evaluation requirements. For most courses, a Transcript of Record is provided in order to gain modular ECTS credits awarded by the UZH.
- It is the participant's responsibility to verify the validity of the course and validate it at their home university prior to participating in the UZH International Summer Schools.
- UZH International Summer Schools shall not be liable if the credits fail to be recognized at the home institution.

Duties and Obligations of the Applicant/Participant

- Participants of the UZH International Summer Schools shall comply with the general regulations (such as house regulations) set out by the UZH. If this is not adhered to, participants may be excluded from the program at short notice.
- Participants of the UZH International Summer Schools obtain the status of a short-term student at the UZH for the duration of the program.
- Participants of the UZH International Summer Schools are responsible for ensuring that they
 acquire any necessary travel documents or visa requirements to enter Switzerland
 rightfully.
- Participants are responsible for procuring the appropriate insurances (civil liability, accident and health insurance) during their time at the UZH International Summer Schools.
- Participants shall assume all the costs associated with their participation in the UZH International Summer Schools, including travel and subsistence.



Duties and Obligations of the UZH

- The UZH International Summer Schools reserves the right to cancel a program. The
 cancellation of the program will be communicated by email and on the website no later than 6
 weeks prior to the start of the course.
- Any tuition fee including housing booked through Global Student Experience will be fully refunded in case of cancellation of the course by the UZH.
- Any other expenses will not be refunded by the UZH International Summer Schools, which
 are the sole responsibility of the participants, who should keep this in mind when making
 travel and/or accommodation arrangements independent of the options offered through
 Global Student Experience.

Cancellation by the Participant

Once an applicant has accepted their place and paid the first installment of the tuition fee,
participation cannot be cancelled. If a participant cancels their enrolment, interrupts the
course and is excluded, or ends it prematurely, no refunds will be provided. If the applicant is
not able to participate in the UZH Summer School through no fault of their own (e.g. illness)
the tuition fee shall be refunded by the UZH only upon presentation of a valid official medical
certificate prior to the start of the course stating the applicant's inability to attend the
respective course.
